Tourism industry welcomes 9% VAT extension

Industry representative group says VAT extension and TBESS expansion will help

20,000 businesses as they face a challenging year

Ireland - February 21st, 2023: The Irish Tourism Industry Confederation (ITIC) has today welcomed Government's decision to extend the 9% VAT rate for the sector and the expansion and simplification

of the Temporary Business Energy Support Scheme.

Elaina Fitzgerald Kane, Chair of ITIC, said "Ireland's tourism and hospitality industry is relieved that the

9% VAT rate is to be maintained for a further 6 months as it is a vital tool to enable the continued

recovery of tourism".

Tourism is the country's largest indigenous industry and biggest regional employer. A report by

economist Jim Power commissioned by ITIC last month had found, in the event of an increase in the

VAT rate, that there would be an inflationary impact of 4.1% on accommodation and food services

and that 24,000 jobs would be at risk.

Fitzgerald Kane acknowledged the support of Tourism Minister Catherine Martin saying that "she

quickly recognised the challenges facing the sector and brought the argument effectively to the Cabinet

table." She said Ministers McGrath and Donohoe had responded constructively to industry concerns.

Eoghan O'Mara Walsh, CEO of ITIC, welcomed today's announcement by Government but said that

tourism still facing a very challenging time "business costs continue to escalate, there is an acute supply

shortage, and key source markets are looking vulnerable". He urged Government to maintain pro-

tourism policies on an ongoing basis saying "There are 20,000 businesses in this sector, the majority of

which are SMEs, labour-intensive and in regional Ireland. The full recovery of tourism to Ireland is not

expected until 2026 so there is quite a climb ahead".
